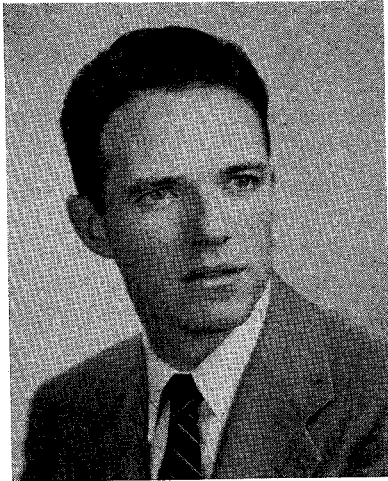

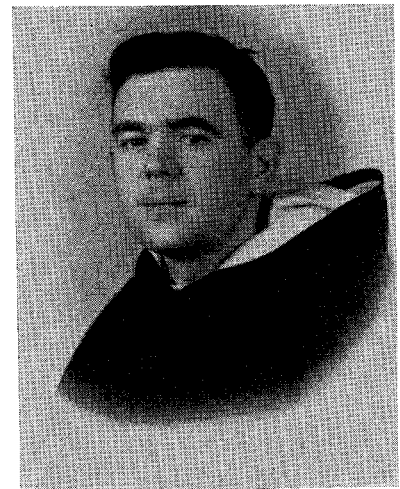
OUR AUTHORS

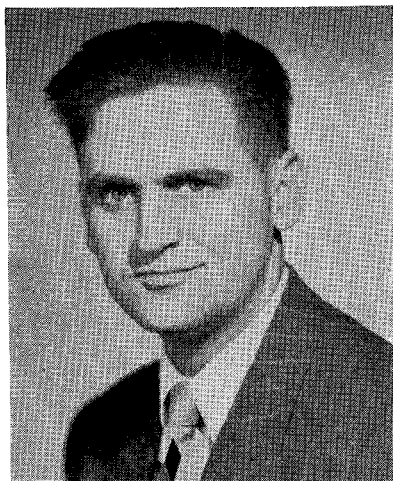
Reverend William F. Cahill is a priest of the Diocese of Albany where he has served as Vice-Chancellor, Vice-Officialis and Pro-Synodal Judge of the Diocesan Tribunal. He is a graduate of Manhattan College, and holds the degree of Doctor of Canon Law summa cum laude from the Pontifical Institute of Civil and Canon Law at the Lateran University, Rome. Father Cahill is Professor of Comparative Law and teaches courses in the Canon Law of Marriage and of Property in the Graduate Division of the School of Law of St. John's University.



Joseph D. Garland, a graduate of Holy Cross College and of Columbia University School of Law, was an editor of the Columbia Law Review. He was associated with Willkie, Owen, Farr, Gallagher and Walton of New York from 1948 until 1954 when he joined the Faculty of St. John's University as Associate Professor of Law. He is active in the Sections on Taxation in the American Bar Association and the New York State Bar Association.

Reverend Dominic P. Hughes, O.P., received the degree of Doctor of Sacred Theology from the Pontifical Faculty of the "Angelicum" in Rome, where he later held the chair of Dogmatic Theology. Father Hughes has also taught in Providence College and in the Immaculate Conception College of Catholic University, Washington, where he was Professor of Moral Theology. At present he is Assistant Professor of Sacred Science in the Graduate School of St. John's University.





Frederick J. Ludwig is a graduate of Cathedral High School as well as a Phi Beta Kappa graduate of the College of the City of New York. He ranked first in his class at Columbia Law School. Professor Ludwig was formerly counsel to the District Attorney of New York County and Acting Captain in the Police Department of the City of New York. He was professor of law at the University of Nebraska from 1948-1950 and presently holds a similar rank at St. John's University. In addition to a case book on criminal procedure and many legal articles, he wrote the widely circulated petition citing international precedent that was instrumental in mobilizing efforts to obtain the release of Archbishop (now Cardinal) Aloysius Stepinac.

Reverend Joseph T. Tinnelly, C.M., the Editor of THE CATHOLIC LAWYER, is a priest of the Congregation of the Mission, the Vincentian Fathers who administer St. John's University. After ordination he studied law at St. John's and upon being admitted to the bar pursued graduate studies at the Harvard Law School where he received a Master of Laws degree and at Columbia University where he is presently a candidate for the degree of Doctor of the Science of Law. Father Tinnelly is Chairman of the Committee on Professional Ethics of the New York State Bar Association and Chairman of the Committee on Legal Education of the Brooklyn Bar Association. He was appointed Acting Dean of St. John's University School of Law in 1948 and Dean in 1952.
