The New York and London Meeting of the American Bar Association

July 14-16, 24-30, 1957

CATHOLIC LAWYERS WHO PLAN to attend the New York and London meeting of the American Bar Association (July 14-16 for the New York portion and July 24-30 for the London portion) should note the following items which are corrections of or which were not contained in the partial program which was officially announced on April 7, 1957.

Sunday— July 14, 1957 — New York City

Mass at 10 a.m. at St. Patrick's Cathedral, Francis Cardinal Spellman presiding. Sponsored by the Guild of Catholic Lawyers of New York.

Wednesday — July 24, 1957 — London

Votive Mass of St. Thomas More at 9:30 a.m. at Westminster Cathedral. (Not to be confused with the service at Westminster Abbey at 10 a.m.)

Wednesday — July 24, 1957 — London

Pilgrimage on the Thames River to Chelsea, the site of St. Thomas More's home, and to the Tower of London where he was imprisoned prior to his execution. Pilgrimage under the auspices of the St. Thomas More Society of London and the Companionship of St. Thomas More, will be conducted by the Very Reverend G. Laurance Goulder. Boat will leave Westminster pier at 1 p.m. Time is of the essence on account of the river traffic. A box luncheon will be provided since most of the pilgrims will come directly from the fourth session of the Assembly which will be held in Westminster Hall at 11 a.m. Tickets for the river journey, the return by coach from the Tower of London and the luncheon will be one guinea (about three dollars) which will just defray the cost.

Because of the limited facilities available, only 200 members of the American Bar Association can be accommodated. Reservations should be made as soon as possible in care of
